obtained at the Election Commission Office at the Grundy County Courthouse**

**Qualifying deadline for these offices will be Thursday, December 14, 2023  
at 12:00 Noon in the Grundy County Election Commission Office**

**Independent Candidates wishing to run for these offices will have the same  
qualifying deadline and their election will be August 1, 2024**

The last day to Register to Vote is Monday, February 5, 2024
